

Subject: Bringing UG courses in Management & Computer Applications under AICTE Regulations

Respected Madam/Sir,

As you are aware, "Technical Education" and its related aspects are controlled and governed by the All India Council for Technical Education Act, 1987. Section 2(g) of the AICTE Act defines Technical Education:

"Technical Education" means Programmes of education, Research and Training in Engineering Technology, Architecture, Town Planning, Management, Pharmacy and Applied Arts and Crafts and such other Programme (or) areas as the Central Government may, in consultation with the Council, by notification in the Official Gazette

Till date, the AICTE was regulating only the Post Graduate Programs in Management (MBA) and Computer Applications (MCA). However, from next academic year, AICTE has decided to regulate institutions offering BBA, BMS & BCA courses in view of maintaining uniform quality & academic standards across Management and Computer Applications Programs on the similar lines of Post Graduate Courses/Programmes (MCA/MBA).


As informed by the AICTE, approved Institutes have benefits like, Faculty Development Programs, Scholarship Schemes for students, Model Curriculum, Free access E-Books in Indian Languages through e-Kumbh Portal, Margdarshan Scheme for Institutions, PARAKH - Performance Analysis and Review for Holistic Development, etc.

The State Public Universities are requested to communicate the above information to all its affiliated institutions which are offering or intend to offer programmes/courses in BBA, BMS & BCA, for compliance.

Sub: Request to direct all Universities in the state to instruct their affiliated colleges offering UG courses in Management & Computer Applications (BBA/BMS/BCA) to mandatorily take AICTE approval.

Respected Sir,

Greetings from AICTE wish you a very happy and prosperous new year!

I wish to draw your kind attention on a matter of utmost importance that pertains to the regulatory framework governing undergraduate courses in Management and Computer applications (BBA & BCA) and request your support.

As you aware, 'Technical Education' and related aspects are controlled and governed by the All India Council for Technical Education Act, 1987 (For short, 'AICTE Act'). As mentioned in its Chapter 2-g:

(g) "Technical Education" means Programmes of education, Research and Training in Engineering Technology, Architecture, Town Planning, Management, Pharmacy and Applied Arts and Crafts and such other Programme (or) areas as the Central Government may, in consultation with the Council, by notification in the Official Gazette, declare;

Till date AICTE was regulating only the Post Graduate Programs in Management (MBA) and Computer Applications (MCA). Considering the letter and spirit of AICTE Act, from next academic year (2024-25), AICTE will be regulating institutions offering BBA, BMS & BCA courses in view of maintaining uniform quality & academic standards across Management and Computer Applications Programs. Moreover, now UGC has also issued notification (copy attached) supporting our decision.

Further, a committee has been constituted to prepare the model curriculum of these programmes that also include mandatory internship. Also, appropriate changes have been made in the next year Approval Process Handbook without disturbing their existing Academic, Administrative and Affiliation Structure, so that institutions are clearly aware about AICTE Norms & Regulations which these institutions need to follow.

In view of the foregoing, we request you to direct all the State Public Universities (Affiliating Universities), Non-Technical/Technical institutions, Institutions Deemed-to-be-Universities & Private Universities to take AICTE's approval for their BBA/BMS/BCA courses. Moreover, we also request you to kindly direct the State Public Universities to instructed all their affiliating Institutions which are offering or intend to offer Programmes / Courses in BBA, BMS & BCA to take AICTE approval.

Sir, you may even take this opportunity to highlight the importance of AICTE Approval along with the advantages the institutes will get eg: Faculty Development Programs, Scholarship Schemes for students, Model Curriculum, Free access E-Books in Indian Languages through e-Kambh Portal, Margdarshan Scheme for Institutions, PARAKH - Performance Analysis and Review for Holistic Development, etc.) by obtaining Approval.

We hope you will consider our request positive considering our goal to improve quality of higher education in India. Also request you to kindly share with us the copy of your letter to these Universities/institutions which we may refer to while subsequent engagements with them.

PUBLIC NOTICE OF FACILITATION CENTRES FOR GENERAL DEGREE COLLEGES RUNNING BBA/BMS and BCA PROGRAMMES/COURSES.

As per the provisions envisaged in Approval Process Handbook 2024-27, all institutions/Institutions Deemed to be Universities offering the Programmes BBA/BMS/BCA need to seek approval from AICTE. In order to facilitate the existing institutions running BBA/BCA/BMS Programmes to submit the online applications seeking approval, the Council has setup 100 facilitation centres across the Country to convene an Application Submission Camp. The list of facilitation centres, contact details, the schedule of camp and the list of documents to be furnished at facilitation centres for successful submission of applications are available at www.aicte-india.org (link-https://aicte-india.org/sites/default/files/Approval_Facilitation_Centre.pdf). All institutions /Institutions Deemed to be Universities are requested to avail this facility so as to enable us to complete the process on time.

For this the stakeholders as mentioned can also visit the webpage of AICTE portal (link-<https://www.aicte-india.org/bureaus/approval/approval-process-2024-25>) which is dedicated for providing guidelines to fill the form; information on the benefits in the form of schemes/programs they can avail on getting AICTE Approval, etc.

** Central Universities/ State (Public/Private) Universities need not to take AICTE Approval, but if they intend to take the benefit of AICTE Schemes/Program, AICTE approval is required.
