It is notified to all concerned affiliated Special Education Colleges with the University of Rajasthan, Jaipur (under Jaipur & Dausa Districts) that online application forms for granting Fresh/Extension of Provisional/Permanent affiliation, affiliation with Increase Intake/New Courses/New Subjects for the academic session 2024-25 shall be started with following affiliation fee structure/schedule of dates w.e.f. 26th May, 2024 on the University Online Portal <https://ruaffiliation.in> :-

- As per clause 3.2.2 of UGC Regulation 2009, the prescribed endowment fund is Rs. 35 Lakh FDR per programme for Professional courses. The Colleges will deposit enhanced endowment fund, if the final judgement of the Hon'ble High Court Rajasthan comes in favour of University of Rajasthan, Jaipur, till date existing norms for endowment fund shall be applicable. The deposition of FDR towards endowment fund is necessary for each and every affiliated or to be affiliated colleges subject to final verdict of the Hon'ble High Court.
- The cost of online affiliation form for Fresh/Extension/Increase Intake will be **Rs. 1330/- per form and Rs. 6650/- per form for permanent affiliation.**
- The Colleges will have to deposit the fee of Rs. 800/- per seat in each programme at the commencement of U.G. degree or P.G. degree courses shall be chargeable every year irrespective of new affiliation, permanent affiliation, increase of seats, extension and affiliation of additional subject and courses w.e.f. the session 2018-19, if the final judgment of the Hon'ble High Court Rajasthan comes in favour of University of Rajasthan, Jaipur.

3. The Colleges will have to deposit the fee of Rs. 800/- per seat in each programme at the commencement of U.G. degree or P.G. degree courses shall be chargeable every year irrespective of new affiliation, permanent affiliation, increase of seats, extension and affiliation of additional subject and courses w.e.f. the session 2018-19, if the final judgment of the Hon'ble High Court Rajasthan comes in favour of University of Rajasthan, Jaipur.
4. For grant of extension of Provisional Affiliation for Professional Courses the full affiliation fee (i.e. 100% amount) shall be applicable.
5. Section-wise increase intake affiliation fee will be charged separately i.e. Rs. 88,580/- per section.
6. Re-inspection Fee shall be charged @ Rs. 26,620/- per course as per BOI Resolution No. 18 dated 07.10.2014.
7. The Colleges applying for fresh/increase intake/additional/permanent subject affiliation are required to pay Inspection fee of Rs. 13,310/- for each course as per BOI Resolution No. 18 dated 07.10.2014.
8. The hard copy of the affiliation form alongwith all the required supporting documents to be deposited by the college itself in the Academic-II Section within 15 days from the date of uploading the same, failing which a fine of Rs. 600/- per day will be charged from the concerned College.
9. Original FDR towards endowment fund shall be presented at the time of submission of hard copy of the affiliation forms.
10. No Objection Certificate of the State Govt. must be uploaded while online submitting affiliation form and the same is required to be submitted as hard copy of the same alongwith affiliation forms in the stipulated time/duration.
11. If your College has been accredited with NAAC by the UGC, a copy of the same be uploaded and submitted with affiliation forms. If not obtained, than the College may take initiatives to get NAAC accreditation from the UGC.
12. The existing College will be required to fill the affiliation form with mentioning AISHE code already given by the concerned authority, whereas the new Colleges shall have to apply for new AISHE code for the purpose.
13. The University shall only entertain those colleges which filled online affiliation form with requisite affiliation fee deposited in time in University Bank Account. In case the transaction of deposition of affiliation fee is failed and the same is not deposited in University account shall not be considered for affiliation.
14. The affiliation fee shall be refundable by deducting 25% amount towards processing charges in case the inspection is not conducted. No affiliation fee shall be refundable/adjustable in such cases where the respective inspection team has not recommended fresh/increase intake or extension of provisional affiliation.
15. All the colleges shall have to follow the provisions/norms so prescribed under the University ordinance/statutes/directions to be issued time to time by the University.
16. If a college which is under provisional affiliation of the University, fails to apply for extension of provisional affiliation for a particular academic session upto the last date, than the concerned college shall be deemed to be disaffiliated from the University from such academic session, thereafter such college, if want, to apply for next academic session than it shall be required to deposit the fresh affiliation fee again (with prescribed penalty and late fee) in University as applicable for the concerning courses than the last academic session shall be declared as zero session and the extension of provisional affiliation shall be considered to be granted for the next academic session accordingly.
17. The affiliation fee to be deposited through online Payment Gateway System by multiple payment modes like Credit Card/Debit Card/Net Banking and Wallets by the respective College at Nil charges.

18. All the colleges shall have to deposit 18% GST amount of the total affiliation fee in case the CGST office takes any decision in future (what so ever) for the same. The necessary directions shall be given to the colleges after intimation of the CGST office.
19. If it is found at any stage on checking of affiliation forms that the affiliation fee deposited by the college found less as per above said affiliation fee schedule than the difference amount of affiliation fee must be deposited by the concerned college at only online affiliation fee portal.
20. Every and each college must ensure to fill online category-wise affiliation form (i.e. Fresh/Extension of affiliation/Permanent affiliation/Increase Intake or other categories) failing which their affiliation matters shall not be considered under any circumstances.
