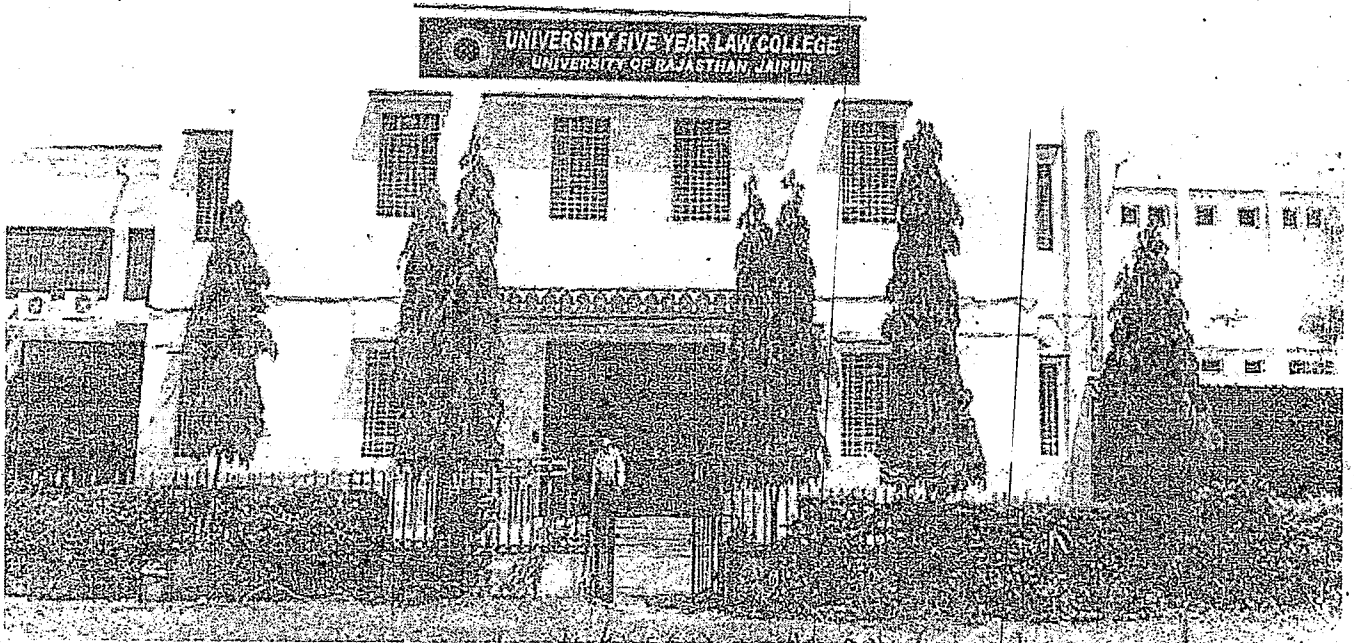

## SUBMISSION PROCESS

Rajasthan Journal of Juridical Science welcomes original and previously unpublished articles, notes, comments, and book reviews for publication in its upcoming issue (Vol. V, Issue I 2025).

Submissions for the upcoming issue will be accepted till **March 05, 2026 before 11.59 PM**. No further extension shall be given.

The submission of the manuscripts should be in **MS Word** and sent by the aforesaid date and time on the following Google form link ..... All submissions must comply with the style guide suggested below.

## IMPORTANT GUIDELINES REGARDING THE SUBMISSIONS

### Authorship

- Co-authorship up to two authors is allowed (One author & one Co-author).
- Academicians, professionals, doctoral researchers are invited to submit their work.


### Word Count

- **Short Articles** are typically of around **1500-2000 words**.
- **Long Articles** are typically of around **2500-3500 words**.
- **Notes and Comments** are short pieces of less than **3000 words**. (These are assessments of the aim and legal impact of contemporary judgments and legislations).
- **Book reviews** are generally around **2000-3000 words**. (Entries submitted under this category may present innovative evaluations of present literature instead of merely providing a summary of its main arguments).

All the above-mentioned word counts are inclusive of footnotes.

### Format and Citation

- Font type and size of the main text must be Times Roman, 12.
- Font type and size of the footnotes must be Times Roman, 10.
- The main text and footnotes must have a line spacing of 1.5 and 1 respectively.
- Citation style must adhere to **OSCOLA (4<sup>th</sup> edition)** and **APA**.

- Each submission (except Book Review) should be accompanied by an abstract of not more than 250 words and five keywords.
- First page of the Manuscript shall include the Title of manuscript, Name of Author/s, Designation of author/s. The Main body of the text must start from the second page of the manuscript including abstract.
- Manuscripts must be in **MS-Word (doc./docx.)** format.

#### Plagiarism

- The submitted manuscripts would be scrutinized for plagiarism through antiplagiarism software
- The similarity above 10% will be ground for complete rejection of the paper as per UGC directions.

#### Submission

#### Review Process

- The review process follows an anonymous, independent, and robust approach.
- The submissions undergo a double-blind peer review process, in which the identities of the authors and reviewers will be concealed from one another.
- The editors aim to, as far as possible, complete the review process, from submission of the manuscript to a publication decision, within 3-5 weeks. If the manuscript is accepted for publication, the decision shall be communicated to the author within 4-6 weeks of the submission.


#### NOTE:
