8. Delivery of the supplied item(s) shall be completed within seven (07) days from the date of issuance of the purchase order.
9. The Procuring Entity reserves the right to accept or reject any or all quotations, wholly or partially, and to cancel the bidding process at any stage without assigning any reason.
