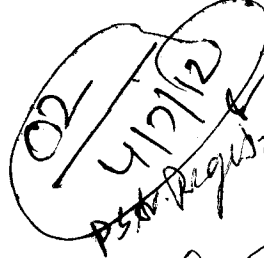

It may be noted that non compliance of UGC Regulations will invite necessary action against the institutions as prescribed vide para no. 9.4 of the UGC Regulations. The name, e-mail address/mobile number of the nodal officer to whom the complaints of ragging can be made should also be uploaded on the website of the institution and also intimated to UGC.

You are requested to initiate action in the matter immediately & ensure that all anti-ragging measures are in place before the start of the academic session 2012-13.
